Previous board experience is not necessary, and we specifically welcome applications from those underrepresented in our sector, including minority ethnic, LGBTQI+ and Disabled voices.

Board members are invited for a 2-year term, during which they will:

Board members also provide some ad-hoc support via email. We are recruiting members to join for a 2-year term.
